HCBA SUSTAINING MEMBERSHIP

The Board of Directors of Hampden County Bar Association provides members of the legal community with a way to demonstrate their support of the local Bar Association: the designation of “**sustaining member.**”

To become sustaining members, in addition to members’ annual dues, individual attorneys and non-attorneys may contribute \$50/year, judges may contribute \$75, firms with two to five attorneys may contribute \$100/year, firms with six to fourteen attorneys may contribute \$200/year, and firms with fifteen or more attorneys may contribute \$300/year.

Those judges, individual attorneys, non-attorneys and firms who contribute as sustaining members will not only derive satisfaction from the knowledge that their additional contribution will assist with the Bar’s various functions, programs and activities, but they will also have their names (individually for judges; individual attorneys; non-attorneys; and, firm names for firms listed) as a side-bar on each edition of the Hampden County Bar Association newsletter generated monthly for which the contribution is made.

As an added benefit to our **Sustaining Members**, we will hyper-link your firm/individual web-page from your name on the HCBA website. What this means is if someone viewing our Newsletter on our website clicks on your name in the Sustaining Membership listing, they will automatically be connected to your web page (if you have one). This is a great marketing opportunity!
